Regular Meeting of January 12, 2021**

The Regular meeting of January 12, 2021 was called to order at 6:00pm with review and approving vouchers. At 7:00pm the Board opened up with a Prayer and Pledge of Allegiance.

Present: Supervisor Strosahl, Clm. Reichert and Clm. Williams. Clm. Brixey was excused from the meeting and Clm. Douglas was absent.

Others Present: Attorney Pelella, Town Clerk Dence and Town Engineer Murray.

M-2 Clm. Reichert moved, seconded by Clm. Williams to accept the Minutes of December 8, 2020 as presented. Motion Carried

M-3 Clm. Williams moved, seconded by Clm. Reichert to accept the Minutes of December 15, 2020 Special Meeting. Motion Carried.

M-4 Clm. Reichert moved, seconded by Clm. Williams to accept the Minutes of January 8, 2021 Re-Organizational Meeting as presented. Motion Carried.

M-5 Clm. Reichert moved, seconded by Clm. Williams to approve the vouchers on Abstract 14 of 2020 as follows: General Fund Claim numbering 356-368 in the amount of \$4,181.12 and Highway Fund Claim numbering 185-193 in the amount of \$21,582.37. Roll Call Vote: Strosahl-aye, Reichert-aye and Williams-aye.

M-6 Clm. Reichert moved, seconded by Clm. Williams to approve the vouchers on Abstract 1 of 2021 as follows: General Fund Claim numbering 1-7 in the amount of \$17,928.77 and Trust and Agency numbering 1 in the amount of \$100. Roll Call Vote: Strosahl-aye, Reichert-aye and Williams-aye.

Monthly Reports of the Supervisor, Code Officer, Dog Control and Town Clerk were presented to the Board.

Committee Reports

Assessor – Clm. Reichert had nothing to report. Supervisor Strosahl stated Assessor Spaulding asked for the summer off he then commented that they will be looking for a new Assessor.

Buildings & Grounds – Clm. Reichert had nothing to report.

Code Enforcement – Supervisor Strosahl reported that an Annual Report for 2020 will be submitted in time for our next meeting.

Justice – Clm. Williams said that Mari Townsend was installed as Town Justice and will be holding court at night. District Attorneys are available days and considering nights.

Cemeteries – Clm. Williams stated he had a request for a plot in Woodbridge Cemetery.

Highway – Supervisor Strosahl got Superintendent Noble on the phone who has submitted the Highway Inventory for Equipment. The plow and sander have been installed on the pick-up truck. Noble talked to Highway Commissioner Gary Hammond who stated FEMA claims for the blizzard of 2021 have been submitted. Strosahl commented that the old Ford truck has been stripped down and the window shield will be replaced and will be inspected so that the Code Officer can use it.

David Yoder asked for the Town to open 890 feet at the end of Newman Road which is seasonal and they will add 100 x 100 feet turn around for the milk truck.

Dog Control – Clm. Williams reported that Officer Liske turned in her monthly report.

Planning Board – Supervisor Strosahl stated the Board had a virtual training session on January 7 here at the Town Hall and they are still seeking a secretary.

Board of Appeals – Clm. Williams had nothing to report.
